**REGULATIONS**

1. Title and commencement - (1) These regulations may be cited as the International Companies (Prescribed Fees) (Amendment) Regulations 2007 and shall be read together with and deemed part of the International Companies (Prescribed Fees) Regulations 1982 ("the principal regulations").

(2) These regulations shall come into force on the 1<sup>st</sup> day of July 2007.

2 **International Companies (Prescribed Fees) (Amendment) Regulations 2007**

2. Prescribed fees - The principal regulations are amended by deleting the Schedule (as inserted by the International Companies (Prescribed Fees) (Amendment) Regulations 2006) and substituting the schedule set out in the Schedule to these Regulations.

3. Revocation - The International Companies (Prescribed Fees) (Amendment) Regulations 2006 are revoked.
