Regulations

- 1 Title**
These regulations are the International Companies (Prescribed Fees) (Amendment) Regulations 2014.
- 2 Commencement**
These regulations come into force on 1 April 2014.
- 3 Principal regulations amended**
These regulations amend the International Companies (Prescribed Fees) Regulations 1982.

4 Schedule (Prescribed Fees)
